PRB-II, 5#/sk gilsonite, 1/4#/sk flocele (181 cu.ft.). Circulated 40 bbls cement to surface. WOC. Bumped plug @ 2:15 pm on 6/29/2011. Plug held. NU BOP. Test BOP to 250# low - 15 minutes and 2000# high - 15 minutes. Pressure test casing to 1500# - 30 minutes - ok.
