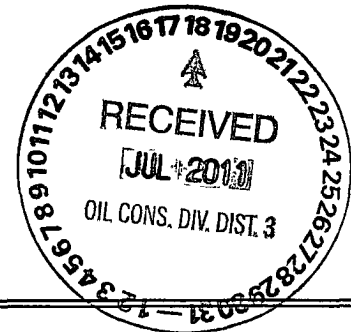

The San Juan 30-4 Unit #64H was delayed at the end of 2010 due to national forest closure. Energen Resources has contracted for a rig to be built and moved into the basin in order to drill this and our other challenging wells in 2011. There have been multiple complications in the construction of this rig and the original delivery date of April 15th has been delayed to August 1st. This has caused Energen Resources to delay resuming drilling and the completion of the #64H. This well will be completed before the forest closure on 11/1/2011
