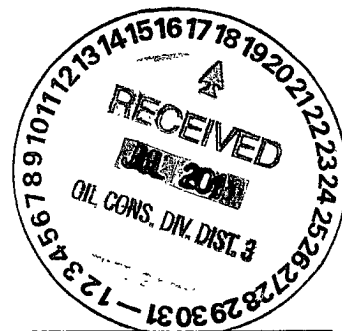

Cement with 717 sks 65/35 with 6% Bentonite, 2% CaCl, 10#/sk gilsonite, 1/2#/sk floccle tailed with 150 sks Class G, 1/4#/sk floccle. Circulate 100 bbls of cement to surface (1582.32 cf) Plug down at 4:00 pm on 7/9/11. WOC. Test BOP to 220# low - 15 minutes and to 2000# high - 15 minutes - ok. Pressure test casing to 1500# - 30 minutes - ok.
