Proposed Procedure:

1. MIRU. POOH w/ 2-3/8", 4.7#, N-80 EUE tbg & 4-1/2" pkr. LD pkr.
2. RIH & set CIBP @ 9500'. Press test 4-1/2" csg to 1000psi. Cut 4-1/2" csg @ 7450'.
3. PU on 4-1/2" csg and remove csg slips. Attempt to pull csg free. POOH while LD 4-1/2" csg.
4. RIH w/ 6" bit, scraper & 2-3/8" tbg to 7450'. POOH w/ tbg, scraper & bit. LD scraper & bit.
5. MIRU WLT & run GR-N-CCL log f/ 7000'-7430'. RIH w/ CIBP and set @ 7420'. Dump 20' cmt on top. Press test 7" csg to 1000psi.
6. RIH w/ 3-3/8" csg gun loaded at 2SPF and 180 deg phasing. Perf L. Mancos f/ 7150'-7317'.
7. RIH w/ 7" Arrowset tension pkr, 1.78" ID SN & 2-3/8" tbg. Set pkr @ 7100' w/ 8000# tension. Press test backside to 500 psi.
8. Swab test well. If well comes in, flow test to tank.
