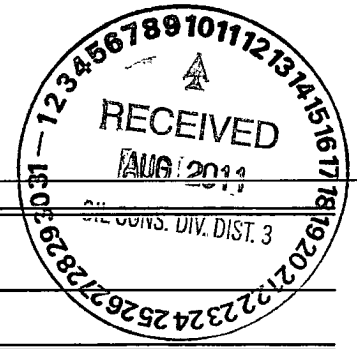
Perforations are at 4829'-7867' - pre perforated 4.50", 11.6#, J-55 liner.
