Pull & lay down 16' polish rod with liner, 1 ea 2' & one 6' x 3/4" pony rods with molded guides, 4 ea 1-1/4" sinker bars, no tap tool & 2"x1-1/2"x12' RHAC-Z Pump. NDWH, NUBOP. Pull tbg, seating nipple & tail joint. (total 17 joints 2-3/8"). Tally & ran 4-1/2" csg scraper & tbg. Work scraper across & above perfs. Pull tbg & scraper. SDFN. On 5/21/2019 held safety meeting. Ran CIBP & tbg. Setp CIBP @ 440'. Lay down 1 jt. Circulate well with fresh water. RU & press test to 500 psi. Batch mix & pump 39 sks 15.8" class G cmt. Pull tbg & stinger. NDBOP. Mix & top off w/ 20 sks 15.8" class G cmt, RDMOSU. BLM witnessed pressure test & cmt.
