7/20/211 Spud well @ 5:30 pm on 07/20/11. Drill 12.25" hole to 200'. Run 4 jts. 8.625" 24# J-55 ST&C casing, set @ 195'. Cement with 140 sks Type V, 2% CaCl₂, 1/4#/sk poly-e-flake. (168 cf) Circulate 12 bbls cement to surface. Plug down @ 2:30 am on 07/21/11. WOC. NU BOP. Tested BOP 250#, low - 10 minutes and 2000#, high - 15 minutes - ok. Tested surface casing - would not hold - dump sand and still would not hold. Wait on 8.625" packer, set at 92'. Pressure test casing to 750#, but lost 200# in 30 minutes. Witnessed by Ray Expinosa and Leo Pacheco of BLM. BLM approved to continue drilling and will witness production casing cement job.
