Record clean up: The subject well's APD submitted on 9-26-1995 had the well location at 1305 feet FNL and 1815 feet FEL. Subsequently, a revised C-102 plat dated 11-02-1995 with revised footage of 1275 feet FNL and 1815 feet FEL was filed without a sundry notice. The north 1275 footage was not reflected on all of the subsequent well record documents and sundries. It appears the revised 1275 footage is accurate on current aerial views. Please revise the north footage accordingly. The East footage did not change. The revised C-102 is attached.
