2/5/2020 Continue to TOO, w/ 2-3/8" tbg while scanning tbg. RD scan X. MU mill & BHA. TIH, f/surface to 6243'. TOO, w/ 2-3/8" tbg & mill assembly. Rig froze up. Broke air lines. Installed Methanol. TIH, w/ CBP & set @ 5225'. Circ, & CO wellbore. TOO. TIH, w/ packer. Tested f/1822' down to 5225' - good test. Tested f/1729' to surface - good test. Set packer @ 1729'. Made swab runs. Winterize rig. SD for 12hrs to perform inflow test.

2/6/2020 RIH, swab assembly. No H2O was indicated. RD swab lubricator/ Unseat packer. TOO, f/1701' to surface. LD packer. TIH, f/surface to 2498'. Made 13 swab runs. Wellbore stayed dry. Winterize lines.

2/7/2020 Made swab runs. Run showed no water had entered CSG. TOO, w/ tbg. TIH, w/ blade bit & 4
