EPIC Energy, LLC, permanently plugged and abandoned the Atlantic A LS #13 on 6/24/20 – 6/27/20 as follows:

**Plug #1 (2600'-3042'):** Set CICR at 3042'. Pumped 35 sx (41.3cf) Class G w/ 2% CaCl<sub>2</sub>. WOC – confirm TOC at 2600'

**Plug #2 (1590'-1830'):** Shoot 4 spf at 1830', set CICR at 1782'. Pumped 65 sx (76.7 cf) of Class G (47 sx outside casing, 18 sx inside casing). Calc TOC outside at 1586', WOC overnight, confirm TOC inside 4-1/2" at 1590'. Note: started circulating out BH after pumping 10 bbls of cement.

**Plug #3 (surf – 272'):** Shoot 6 spf at 272'. Pumped 142 sx (167.5 cf) of Class G. Cement did not set up properly. RIH and set CICR at 235'. Pumped additional 98 sx (115.6 cf) of Class G cement. Good circulation out BH. Hole staying full both inside and outside 4-1/2". Cut off wellhead and weld on P&A marker. Note: Notified Brandon Powell of P&A operations on 6/23/2020 at 15:09 hrs. All cement used was Class G with yield of 1.18 cf/sx at 15.6 ppg.
