DJR Operating LLC is requesting approval to shut-in the subject well pursuant to IM No. NM-2016-017 due to economics resulting from the low price of oil. No equipment will be removed which could affect the capability of the well to produce. The estimated date when the well will be returned to production is dependent on oil prices; therefore, a specific time frame when the well will be returned to production is unknown.

Pursuant to a telecon with Dave Mankiewicz and Joe Killins on May 6, 2020, DJR will schedule a meeting with the BLM on or before February of 2021 to discuss specifics associated with conducting the production verification test required in IM-2016-017 if the well will be shut-in for 12 consecutive months.
