Total pump time was 22 minutes. 5 minute after SI, tubing was 0 psig. Casing remained at 0 psi the entire time. Removed a check valve from the wellhead piping and put a blind flange in its place. Pressure gauges and chart recorder are in place. Please see attachments.

Hilcorp Energy will not be injecting at this time due to low economic conditions.
