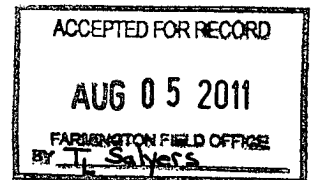

Tail w/70 sx Type III cement + 1% BWOC CaCl₂ + 1/4# celloflake/sx + 0.2% BWOC FL-52A + 59% fresh water (97 cu ft total slurry). Displaced w/28.3 bbls fresh water. Circulate 10 bbls cement to surface. Pressure test will be reported on completion sundry. Released Wayne Smith Drilling on 8/3/11. *AV*
