Set retrievable bridge plug at 2,000'. Pressure test casing above plug at 2,000 psi for 30 minutes, held with no leaks. Perforate Fruitland Coal 1798'-1804' w/4 spf (total 6', 24 holes). Acidized coal interval with 250 gals 15% HCL acid. Ran 2-3/8" tubing to 1796'. Swabbed casing to recover all load water with good gas show. Land tubing in wellhead. This work was completed August 22, 2011.
