7/12/11 MRIU AWS #481. Unseat pump and POH w/rods and pump. ND WH, NU BOP. PT - OK. POOH w/2-3/8", tubing. Hooked up air to C/O fill. RIH w/overshot and tagged fish @ 3402'. Fished for two days during that time noticed that the liner had moved uphole approx. 69'. New TOL @ 3245'. Had chunks of coal come up. 7/21/11 RIH w/ video camera, and saw where we damaged the casing @ 3395' and collapsed casing @ 3402' (damaged while attempting to fish.) TOH w/drill collars. TIH w/111 jts of 2-3/8", 4.7# J-55 tubing and set @ 3399' w/F nipple set @ 3382'. ND BOP, NU WH. RIH w/pump and rods. Spaced out. Installed HH. RD & released rig 7/26/11 @ 1500 hrs.

Note: damaged casing within the original FC interval, so no repairs will be attempted at this time.
