Displace w/5.5 bbls water. Circulate cement to surface. NU BOP. Pressure test csg to 800 psi for 30 mins, held ok; 250 psi for 5 mins, held. Tested blind rams & choke manifolds to 800 psi for 30 mins, held; 250 psi for 5 mins, held. Test pipe rams, Kelly valve & middle choke valve to 800 psi for 30 mins, held; 250 psi for 5 mins, held.
