Tail w/70 sx Type III + 1% BWOC CaCl2 + 1/4# celloflake/sx + 0.2% BWOC FL-52A + 59% fresh water (97 cu ft). Displaced w/24.2 bbls water. Circulate 12 bbls cement to surface. Wayne Smith Drilling released 8/18/11. Pressure test will be reported on completion sundry.
