Proposed perforations are: MV - 3931' - 5045' ; DK - 6662' - 6860' These perforations are in TVD.

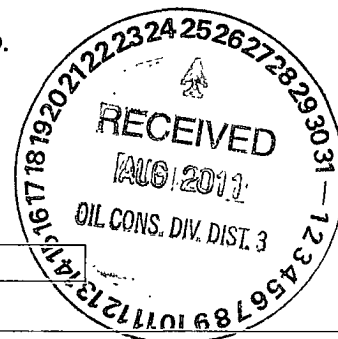
