9/23/11 Completion rig moved onto location. Pressure tested casing to 1500# for 30 minutes - ok.
Perforate the lower FRC 1607'-1614' (4 spf, 28 holes), 1557'-1563' (2 spf, 12 holes).

9/24/11 Two stage frac job. Frac 1st stage with 52,642 gals of x/link in 70Q foam and 2500# of 100 mesh, followed by 158,400# of 20/40 sand. Flush frac. RIH with 5.50" composite frac plug, set at 1518'. Perforate upper FRC from 1476'-1483' (4 spf, 28 holes), 1451'-1453' (2 spf, 4 holes), 1407'-1409' (4 spf, 8 holes). Frac with 40,109 gals of x/link in 70 Q foam, 2000# of 100 mesh, followed by 79,710# of 20/40 sand. Flush frac. Clean out and flow back well.

9/28/11 Clean out with air to top of composite frac plug at 1518'. Drill out composite frac plug. Clean out with air to 1766'. PU off bottom and circulate.

9/30/11 TIH with 2.375" 4.7# J-55 production tubing, set at 1665'
