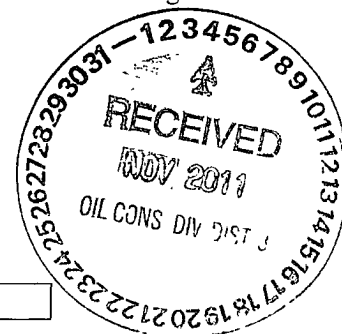
Proposed perforations are: PC - 3096' - 3150' ; MV - 4780' - 5364' These perforations are in TVD.
