10-19-11 – MIRU Mo-Te. Spud 12-1/4" hole @ 0945 hrs TD 12-1/4" surface hole @309' at 1515 hrs. Run 13 jts, 9-5/8", 36#, K-55, LT&C casing, set @ 304' GR. Pump 15 bbls pre-flush & circulate 25 bbls fresh water spacer, dump 101 sxs (28.8 bbl slurry) Type I-II cmt w/ 20% flyash @ 14.5 ppg into csg, drop plug and displace w/ 21.6 bbls H2O, circulate a trace of cmt to surface. Cmt fell back after plug bumped. Will return in the AM to top out cmt.

10-20-11 – Rig up remedial cmt equipment and top out 9 5/8" surface csg w/ 3 sxs neat cmt, circulate 1/4 bbl cmt to surface.

NOTE: Will return after cement cures and run casing pressure test
