Tail w/70 sx Type III cement + 1% BWOC CaCl2 + 1/4# celloflake/sx + 0.2% BWOC FL-52A + 59% fresh water. Displace w/21 bbls water. Circulate 11 bbls cement to surface. Wayne Smith Drilling released on 11/14/11. Pressure test will be reported on completion sundry.
