10/1/11 Spud 12-1/4" surface hole. Drilled to 262'. Ran 6 jts (250') of 8-5/8", 24#, J-55, ST&C new casing and set at 260' KB. Cemented with 155 sx (183 cu.ft.) of Type III with 2% CaCl2 and 1/4 pps polyflake. Circulated 17 bbls of cement to surface. Nipped up the BOP and pressure tested (1,000 psi - high & 250 psi - low) held OK. Drilled a 7-7/8" hole to 3,800'. Ran IES/GR and Density/Neutron logs. Decided to plug the well.
