- Move in and Rig Up well service unit
- Kill well as necessary with viscous fluid
- Trip out of hole and lay down rods and pump
- Trip in hole with cast iron cement retainer to 1140' +/-5'
- Cement through retainer with 60sx cement with 2%CaCl2, pull out of retainer and spot 15sx cement with 2%CaCl2 on top
- Trip out of hole laying down tubing
- Perforate squeeze holes at 300' 336
- Squeeze 150sx cement with 2%CaCl2 down 7 5/8" casing and returning through annulus inside 10 3/4" casing
- Dig out, cut off, install marker, remediate location as indicated in conditions of approval

**CONDITIONS OF APPROVAL**

1. Plugging operations authorized are subject to the attached "General Requirements for Permanent Abandonment of Wells on Federal and Indian Lease."
2. Farmington Office is to be notified at least 24 hours before the plugging operations commence (505) 599-8907.
3. The following modifications to your plugging program are to be made:
  - a) Bring the top of the Pictured Cliffs/Fruitland plug to 868'.
  - b) Place the Kirtland/Ojo Alamo/Surface plug from 336' to surface inside and outside the 7 5/8" casing.

You are also required to place cement excesses per 4.2 and 4.4 of the attached General Requirements.
