Perforations are from 3,242' - 3,374', 4 SPF, 0.48", 120 degree phasing. On 10/29/2004 ran back in hole with 91 jts of 2 3/8" tubing J-55, 4.7#, LT&C, and 16 jts 2 3/8" N-80, 4.7#, LT&C, end of tubing set at 3,452', return well to sales on 10/30/2004.
