Perforations are from 2,976' - 3,236', 0.48", 380 holes, 120 degree phasing. On 12/17/2004 ran back in hole with 109 jts of 2 3/8" tubing J-55, 4.7#, LT&C, end of tubing set at 3,307', return well to sales on 12/18/2004.
