Due to operations recently assumed by Apollo Resources International, Inc. the exact nature of this well & 13 other B C & D wells, identified on BLM letter dated March 14, 2005, as shut in is unknown.

Evaluation of history and possible cost associated with restoration is planned to identify the best wells to restore first.

If satisfactory with the BLM, our proposed plan is to schedule restoring four wells per month to active status beginning June 1, 2005. This schedule may be accelerated if restoration proves economically beneficial.

If work on any given well is suspended due to unanticipated problems to severe to proceed, the well will be P&A'd or T&A'd with proper notification to the BLM.
