Set 17 external swellable casing packers for isolation of production string at: (1) 9224' (2) 8988' (3) 8754' (4) 8520' (5) 8287' (6) 8054' (7) 7820' (8) 7586 (9) 7352' (10) 7118' (11) 6884' (12) 6649' (13) 6415' (14) 6137' (15) 5859' (16) 5573' (17) 4359'.
