Closed-Loop Design Plan:

Dugan Production proposes to use a closed loop circulating system to contain well bore fluid and cement generated during the plugging to abandon procedure on the subject well. The system will not entail any drying pad, temporary pit, below grade tank or sump. The system will consist of an above ground tank with adequate volume to hold all fluid generated during the operation.

- 1. Fencing is not required for an above ground closed-loop system.
- 2: Signage in compliance with 19.15.3.103 NMAC will be present.
- 3. Water will be contained in a 500 bbl water tank or a water truck that will contain only fresh water.

Closed-Loop Operating and Maintenance Plan:

The subject closed-loop system will be operated and maintained to contain liquids and solids in corder to prevent contamination of fresh water sources; and to protect public health and the environment. To ensure that the operation is maintained, the following steps will be followed:
