Drilled 12 1/4" hole to 305' on 4/6/05, set 9 jts of 9 5/8", H-40, ST&C, 32.3# casing at 295'. Cemented w/175 sx (37 bbls) "B" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 10 bbls of cement to surface. Test casing to 1500 psi.

Drilled 8 3/4" hole to 2,875' on 4/9/05, set 68 jts of 7", J-55 LT&C, 23# casing at 2,850'. Cemented lead w/550 sx (144 bbls) 50/50 POZ w/3% Gel, 5# Gilsonite, 1/4# Flocele, 1/10% CFR 3, 4/10% Halad 344 and tail w/75 sx (16 bbls) STD, 4/10% Halad 344. Circulated 30 bbls of cement to pit. Tested casing to 1500 psi.

Drilled 6 1/4" hole to 3,274' TVD on 4/18/05. Underreamed in two stages; 1st stage hole to 9 1/2" from 2,860' to 3,110', 2nd stage hole to 9 1/2" from 3,110' to 3,274'. Utilized natural and air assisted surges to remove near wellbore material. On 4/25/05, set 14 jts 5 1/2" 15.5, J-55 liner at 3,273' with JGS rotating liner hanger at 2,803'. Perforated liner with size 0.49" holes, from 2,860' to 3,159'. Landed 2 3/8" production tubing at 3,247'.
