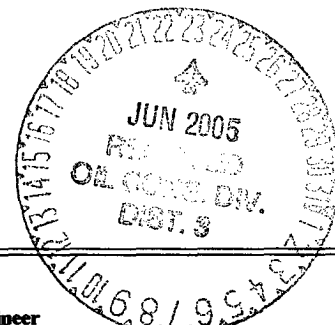

Lance Oil & Gas Company, Inc. has set a bridge plug at 852' KB and re-completed uphole into the Fruitland Coals. The Lower (S-8) and Upper Fruitland Coals (S-9) were perforated and fracture stimulated on 05/20 and 5/25/05, respectively. A Fruitland Coal production test is anticipated to last approximately one month at which time Lance will notify the BLM of our intentions to pull the bridge plug and commingle the Fruitland Coal and Pictured Cliffs.

Lance Oil & Gas Company, Inc. requests approval to commence producing the Fruitland Coal only for a short term test. The BLM will be notified as soon as the production test has been completed.
