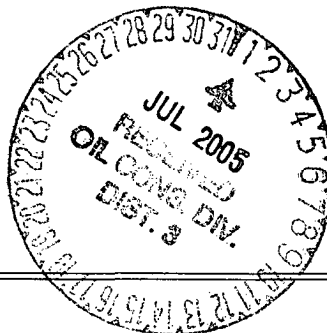

On 3/13/05 ran back in hole with 111 jts of 2 3/8" tubing J-55, 4.7#, LT&C, end of tubing set at 3,357', return well to sales on 3/17/05.
