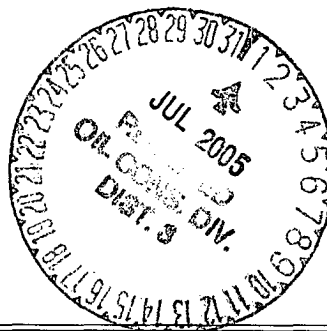

On 5/23/05, set 8 jts of 5 1/2", J-55, 15.5#, LT&C Liner, run to 4,581' with 0 sx of cement. Top of liner hanger is at 4,228'. Perforations are from 4,292' - 4,481', 4 SPF, 0.48", 248 holes, 120 degree phasing. On 5/23/05 ran back in hole with 140 jts of 2 3/8" tubing J-55, 4.7#, LT&C, end of tubing set at 4,483', return well to sales on 5/25/05.
