Casing was repaired as follows:

6/13/05 MIRU. ND wellhead. NU BOP. TOH with tubing and model R-3 packer.

6/14/05 Isolate casing leak from 3569'-3910'. Attempt to pump into leak - pressured up to 1000 psi - pressure leaked off 400 psi in 3 minutes. Could not establish rate.

6/15/05 Spot 40 sx cement from 3400 - 3910'. Pumped 0.6 bbls and well pressured up to 1000 psi.

Hesitate for 30 minutes. Placed 8 sx cement into casing leak. Shut well in over night with 1000 psi.

6/16/05 Drill out cement to 3750'.

6/17/05 Finish drilling out cement. Test casing to 500 psi-ok.

6/18/05 TTH & clean out to PBTD. TTH with 2-3/8" tubing, land @ 6014'. NU wellhead. Return to production.
