Tailed in w/ 1108 sks 65/35/STD POZ w/ 6% Gel, 5# Gilsonite, 1/4# Flocele additives. Circulated 60 bbls good cement to surface. We were unable to run logs so cement was figured at 100% over true hole. Pressure tested to 2500 PSI.
