Elm Ridge Resources, Inc. has spud the above referenced well as of 9-22-04. We drilled a 12 1/4" hole to 378'. Ran 8 5/8" 24# J-55 casing to 374'. Pumped 275 sks of standard cement with 1% Calcium. Circulated 25 bbls of cement to surface. Low test @ 500 PSI and high test @ 1500 PSI.

NOTE: This has been revised from the Jic. B 9 E. There was confusion on what well was drilled.
