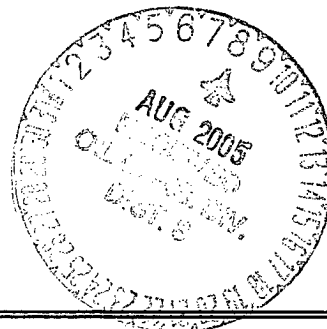

Spud 12 1/4" hole on 7-18-05. Run 8-5/8" 24# J-55 csg. Land @ 122', float collar @ 84'. Cement w/110 sx Class "B" neat w/2% CaCl2 w/1/4# celloflake (130 cu ft total). Displace w/5.75 water. Circ 4 bbls cement. Pressure test BOP to 800#, held ok for 30 minutes.
