Encana Oil & Gas (USA) Inc. (Encana) received Application for Permit to Drill approval on 01/20/2012 for the Escrito 124-2409 01H oil well.

Encana would like to adjust the spacing unit dedicated to this well from 320 acres to 160 acres.

This change is requested due to the 02/15/2012 implementation of revised State of New Mexico oil and gas regulations that define a project area as an area that comprises one or more complete contiguous spacing units that are developed by the well (19.15.16.6 NMAC).

This well is located in the Bisti-Lower Gallup pool, which has 80-acre spacing units designated as the north-half or south-half of a quarter section; and therefore, requires a 160-acre project area comprising the north-half of the south-half of Section 24, T24N, R9W.
