11/5/12 Spud 12-1/4" surface hole. Drilled to 135'. Ran 3 jts (125.65') of 8-5/8", 24#, J-55, ST&C new casing and set at 131' KB. Cmt. with 113 sx (133.3 cu.ft.) of CI "B" with 2% CaCl2 and 1/4 pps polyflake. Circulated 5 bbls of cement to surface. NU BOP and pressure tested the BOP and choke manifold to 250 psi low and 1,000 psi high for 30 min. - held OK.

11/10/12 TD 7-7/8" hole at 885'. Ran 23 jts (876.24') of 5-1/2", 15.5#, J-55, LT&C casing and set at 881' KB. Float collar is at 860' KB. Cement with 110 sx (226.6 cu.ft.) of CI "B" with 2% SMS and 1/4 pps celloflake and 75 sx (88.5 cu.ft.) of CI "B" with 1/4 pps celloflake. Bumped the plug to 1,500 psi - held OK. Floats held OK. Circulated out 25 bbls of cement to surface. Nipped down the BOP and set the casing slips. Cored the main coal from 682' to 701' and recovered 11' of coal. Took four 1' samples for analysis.
