Spud well at 06:00 hrs 9/28/2012. TD 12-1/4" surface hole at 360' at 12:30 hrs 9/28/2012. Run 8 jts of 8-5/8", 24, J-55, ST&C casing. Land casing at 351' KB. Precede cement w/ 20 bbls of gel water. Mix & pump 242 sx (363 cu.ft.) of Type III w/ 1/4#/sx of Cello-flake & 2% CaCl2. Drop plug & displace cement w/ 20 bbls of water. Good circulation through out job. Bump plug to 500 psi - held OK. PD at 17:00 hrs. 9/28/2012. Release pressure & check floats - held OK. Circulated 30 bbls of good cement to surface.

WOC 4 hrs. Cut off casing & weld on braden head. NU 3M BOP. 3rd party pressure test BOP and all related equipment to 250 psi - low for 5 minutes & 1500 psi - high for 10 min. Pressure test casing to 1500 psi for 30 min. All tests good.
