Hole diameter: 6 1/8" production string diameter, 4 1/2" production string weight and grade: 11.6# SB80 LTC. Depth of 6 1/8" hole from 5792'MD to 10350'MD. Float shoe at 10347'MD and float collar at 10336'MD. Production liner set from 5516'MD to 10,347'MD.

Set 18 external swellable casing packers for isolation of production string at the following depths: (1) 5849' (2) 6110' (3) 6330' (4) 6597' (5) 6852' (6) 7113' (7) 7333' (8) 7594' (9) 7855' (10) 8075' (11) 8335' (12) 8594' (13) 8855' (14) 9117' (15) 9337' (16) 9598' (17) 9859' (18) 10079'.
