In accordance with Case # 14878, Order # R-13621, Energen Resources intends to downhole commingle the exisiting Blanco Mesaverde (72319) with Gavilan Pictured Cliffs production (77360). The exisiting MV perforations are 6176'-6348'. Energen intends to set a bridge plug above the MV perforations, then perforate and fracture the PC around 4069'-84103'. Once flowback and cleanout is complete, the bridge plug will be drilled out, tubing landed the well will be put back on to production. Recommended allocation will be by the subtraction method following 60 days of stabilized production. Commingling will not reduce the total remiaing productions value. The interest owners are identical for each zone. Rates will be reported to NMOC-D-Aztec for final determination.


