Preflushed 10bbls & Circ w/ 20 bbls of FW Spacer. Pumped 76sx(122cf-22bbls=1.61yld) Type I-II cement w/ 20% Fly-ash. Dropped plug & displaced w/ 14bbls FW. Bumped plug. Circ. 5bbl cmt to surface. RD cmt. WOC. RD.RR @ 11:45hrs on 01/16/13.

PT will be conducted by Drilling Rig. Results will appear on next report.
