2/6/2013. MIRU spud rig. Spud well at 08:30 hrs. Drilled 12-1/4" surface hole to 338'. Ran 10 jts of 9-5/8", 36#, J-55 ST&C casing. Set @ 333.06'. Pumped 10 bbls pre-flush and circ 45 bbls fresh water spacer. Cemented with 101 sacks (29 bbls) of Type III cement w/ 20% flyash @ 14.5 ppg. Dropped plug at 16:30 hrs and displaced w/ 22 bbls water. Circulated 7 bbls of good cement to surface. RDMO spud rig. Will be bringing in Aztec 781 drilling rig to drill out cement and pressure test the surface casing.

Will supply test data with production casing sundry.
