Set 17 external swellable casing packers for isolation of production string at the following depths: (1) 9664' (2) 9405' (3) 9186' (4) 8926' (5) 8707' (6) 8488' (7) 8227' (8) 8008' (9) 7748' (10) 7530' (11) 7270' (12) 7048' (13) 6830' (14) 6568' (15) 6349' (16) 6089' (17) 5870'
