Burlington completed the subject well Sept. 2012 and had to shut-in the well until the pipeline was built. We recently was able to connect this well to a pipeline, but because it had been shut-in, the well wouldn't flow because it produced too much water. Moved a rig in attempt to dry up the wellbore without luck. Well still making about 4-1/2 bbls/hr, too much to pump off. Isolated the water zone as the Upper Menefee perms @ 3928' - 4148'. Plans are to set a CIBP @ 4200' and a cement retainer @ 3880' and squeeze these perms so the well can be produced. Received verbal approval from Brandon Powell (OCD) and Troy Salyers (BLM) on 2/22/13.

Well will still be a MV/DK well since the Lower Menefee perms and Pt Lookout intervals are still open as is the Dakota.
