Energen Resources would like to recompleate the exisiting West Lindrith Gallup Dakota pool. The existing perfs are from 7330'-7333', 7338'-7358' & 7446'-7456' at 2spf, and the estimated new perforations are 6320'-6504' at 3 spf. A CBL will be run from around 7300' to surface to determine TOC. Then, perforate and fracture. Clean out to PBD, then return full production from all perforations.
