Energen Resources would like to recompleate the exisiting West Lindrith Gallup Dakota pool. The existing perfs are from 7340'-7384' at 1spf & 7452'-7475' at 2spf, and the estimated new perforations are 6334'-6516' at 3 spf. A CBL will be run from around 7300' to surface to determine TOC. Then, perforate and fracture. Clean out to PBTD, then return full production from all perforations.
