Energen Resources would like to recompleate the exisiting West Lindrith Gallup Dakota pool. The existing perfs are from 7315'-7365' at 1 spf & 7429'-7450' at 2spf, and the estimated new perforations are 6314'-6493' at 3 spf. A CBL will be run from around 7300' to surface to determine TOC. Then, perforate and fracture. Clean out to PBTD, then return full production from all perforations.
