The existing perfs are from 7252'-7295', 7365'-7386' at 1spf and the estimated new perforations are 6241'-6419' at 3 spf. A CBL will be run from around 7200' to surface to determine TOC. Then, perforate and fracture. Clean out to PBTD, then return full production from all perforations.
